<p>PE lessons have continued albeit with a streamlined curriculum delivered by Activ Sports.</p> <p>We have maintained the children's involvement in the daily mile initiative as we feel it is important not only in helping children to reach the target of 30 minutes daily activity but also for general health and wellbeing,</p> <p>Children across all year groups took part in Bikeability and balanceability training sessions delivered by Shropshire Council in March of 2020.</p> <p>We have employed the services of a specialist gymnastics coach, Jason Tucker, to improve the pupils' experience of gymnastics teaching and to also serve as CPD for staff who been in the sessions so as to deliver the same unit of work themselves from next year.</p>	<p>We would like to further develop staff confidence in delivering a high quality PE curriculum in a wide range of sports.
